#### 1. PURPOSE

The purpose of this memo is to request appointment of a service provider to provide governance, co-ordinating of meetings, minute-taking and scribing services to the audit and risk committee.

#### 2. SCOPE OF WORK

The prospective service provider would be required to perform the following functions for the Audit and Risk Committee (ARC):

- To advise the ARC, through the Chairperson, on all governance matters.
- To ensure that business of the Commission's ARC is conducted in accordance with its objects as contained in the Audit and Risk Committee Charter, PFMA and Treasury Regulations.
- To prepare the agenda in consultation with the Chairperson and Accounting Officer for all the meetings of the ARC
- To prepare minutes and resolutions of all the meetings of the ARC
- To prepare the draft ARC report for the Chairperson for all meetings for the Commission submission
- To distribute minutes and resolutions within 5 working days from date of meetings
- To follow up on matters arising from meetings and to ensure that responses thereto is obtained and submitted as per agreed upon time frames
- To arrange with and to call and hold meetings of the ARC and to prepare a correct record of proceedings (both electronically and hard copy if so required)
- To call for, collate, prepare, and distribute meeting packs to the ARC Committee members and invitees in the prescribed format
- To maintain a resolution register and to ensure that all resolutions are communicated with the relevant Executive Managers for execution
- To attend the ARC meetings in order to ensure that the legal requirements are fulfilled, and provide such information as are necessary
- To advise, the Chief Executive Officer and Chairperson of the ARC in respect of any legal matters, as required
- To prepare and submit subsistence and travel claims of ARC members.



- To develop tailored induction plans for new ARC members and prepare a training plan for ARC members as agreed upon by the Chairperson and the AO.
- To arrange and ensure proper meeting calls between the Auditor General, Management and all other related parties as and when necessary.

#### 3. SPECIAL CONDITIONS

- ✓ The bidder must be able to attend both Physical and Virtual meetings when required. Meetings within a radius of 50kms will not be charged for travelling costs.
- ✓ When required, the bidder must be able to source recording equipment on behalf of the Commission and a 10% management fee will be paid for this service. The bidder shall be required to obtain and provide three written quotations and the Commission shall select the most suitable quotation for use.

NB: Estimated Number of meetings to be transcribed is: 304 Meeting hours. Working Hours: Average of 8 hrs. per meeting.



(b) information relating to the education or the medical, financial, criminal or employment history of the person;

(c) any identifying number, symbol, e-mail address, physical address, telephone number, location information, online identifier, or other particular assignment to the person;

(d) the biometric information of the person;

(e) the personal opinions, views, or preferences of the person;

(f) correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original

(g) the views or opinions of another individual about the person; and



(h) the name of the person if it appears with other Personal Information relating to the person or if the disclosure of the name itself would reveal information about the person.

**"processing"** means any operation or activity or any set of operations, whether or not by automatic means, concerning Personal Information, including—

(a) the collection, receipt, recording, organisation, collation, storage, updating or modification, retrieval, alteration, consultation or use;

(b) dissemination by means of transmission, distribution or making available in any other form; or

(c) merging, linking, as well as restriction, degradation, erasure or destruction of information;

"record" means any recorded information—

(a) regardless of form or medium, including any of the following:

(i) Writing on any material;

(ii) information produced, recorded or stored by means of any tape-recorder, computer equipment, whether hardware or software or both, or other device, and any material subsequently derived from information so produced, recorded or stored;

(iii) label, marking or other writing that identifies or describes anything of which it forms part, or to which it is attached by any means;

(iv) book, map, plan, graph or drawing;

(v) photograph, film, negative, tape or other device in which one or more visual images are embodied so as to be capable, with or without the aid of some other equipment, of being reproduced;

(b) in the possession or under the control of a responsible party;

(c) whether or not it was created by a responsible party; and

(d) regardless of when it came into existence;

**"responsible party"** means a public or private body or any other person who, alone or in conjunction with others, determines the purpose of and means for processing personal information;

## 3. PURPOSE FOR THE COLLECTION

3.1 The purpose for the collection of your Personal Information and the reason why FFC requires your Personal Information is to enable FFC to:

3.1.1 comply with lawful obligations, including all applicable labour, tax and financial legislation and/or the B-BBEE laws;

3.1.2 to give effect to a contractual relationship as between you and FFC and in order to ensure the correct administration of the relationship;

3.1.3 for operational reasons including the conducting of research;

3.1.4 to protect the legitimate interests of FFC, yourself or a third party;



3.2 All Personal Information which you provide to FFC will only be used for the purposes for which it is collected.

5.1 All Personal Information which you provide to FFC will be held and/or stored securely and held for the purpose for which it was collected, as reflected above.

5.2 Your Personal Information will be stored electronically in a centralised data base, which, for operational reasons, will be accessible to authorised persons within FFC.

5.3 Where appropriate, some information may be retained in hard copy.

5.4 In either event, storage will be secure and audited regularly regarding the safety and the security of the information.

5.5 Once your Personal Information is no longer required due to the fact that the purpose for which the information was held has expired, such Personal Information will be safely and securely archived for a period of 5 years or longer, especially should this be required by any other law applicable in South Africa. Thereafter, all your Personal Information will be permanently destroyed.



## 6. ACCESS BY OTHERS
