## **1. BACKGROUND**

The Financial and Fiscal Commission (FFC) invites proposals from service providers of Sage 300 Payroll and HR support services for a period of two (2) years. The appointed service providers will assist the FFC with monthly payroll services, tax updates and SARS employee returns and technical support with Sage 300.

The Financial and Fiscal Commission (FFC) is an independent juristic entity subject only to the Constitution, Financial and Fiscal Commission Act, 1997 (Act No 99 of 1997), and relevant legislative prescripts. The Commission acts as a consultative body, makes recommendations, and gives advice to the three spheres of Government and other organs of State on the equitable division of revenue and any other financial and fiscal matters.

## **2. PURPOSE**

These Terms of Reference invite potential Service Providers that possess the necessary experience and capabilities to submit a proposal. Request for quotation documents can be downloaded from the FFC's website: [www@ffc.co.za](http://www@ffc.co.za) / Bid Number: **RFQ220603**.

## **3. SCOPE OF SERVICES**

The prospective service provider should have knowledge and experience of processing and reporting on the Sage People 300 system and in offering support to HR and Payroll departments.

The service provider should be able to offer support, as and when required, on the following:

- a) All HR Modules (Leave, Job Grading, Job Profiling, Training and Development, Performance Management, Employment Equity and any other HR module that is on the Sage 300 system
- b) Monthly administration of payroll on the SAGE 300 system and provision of associated reports and journals.
- c) Finance submission of provisional and year tax submissions (EMP501) and other payroll/ finance module that is on the system.
- d) Drawing up of different reports from different modules on the system



- e) Assist with systems maintenance and/or upgrade and other Sage People 300 systems challenges.

#### **4. DELIVERABLES**

1. To provide a support service across all service levels categories, consultants to be available to assist telephonically/online and/ or on-site, as and when required.
2. Leave management and set up, automation of HR processes (recruitment, training and development, performance, etc.)
3. Accurate setup of salary items: basic salary, bonuses, allowances, deductions, gross salary, and net salary for Temporary and permanent staff.
4. Ensuring accuracy and compliance related to statutory regulations including PAYE, UIF, Skill development act, Basic conditions of employment act etc.
5. Client information is treated with utmost confidentiality
6. Electronic production of payslips, regulatory and operating statements (including pension return statements and annual salary declarations.)

- (j) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes.

(c) any identifying number, symbol, e-mail address, physical address, telephone number, location information, online identifier, or other particular assignment to the person;
(d) the biometric information of the person;
(e) the personal opinions, views, or preferences of the person;
(f) correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original
(g) the views or opinions of another individual about the person; and



(h) the name of the person if it appears with other Personal Information relating to the person or if the disclosure of the name itself would reveal information about the person.

**"processing"** means any operation or activity or any set of operations, whether or not by automatic means, concerning Personal Information, including—

(a) the collection, receipt, recording, organisation, collation, storage, updating or modification, retrieval, alteration, consultation or use;

(b) dissemination by means of transmission, distribution or making available in any other form; or

(c) merging, linking, as well as restriction, degradation, erasure or destruction of information;

**"record"** means any recorded information—

(a) regardless of form or medium, including any of the following:

(i) Writing on any material;

(ii) information produced, recorded or stored by means of any tape-recorder, computer equipment, whether hardware or software or both, or other device, and any material subsequently derived from information so produced, recorded or stored;

(iii) label, marking or other writing that identifies or describes anything of which it forms part, or to which it is attached by any means;

(iv) book, map, plan, graph or drawing;

(v) photograph, film, negative, tape or other device in which one or more visual images are embodied so as to be capable, with or without the aid of some other equipment, of being reproduced;

(b) in the possession or under the control of a responsible party;

(c) whether or not it was created by a responsible party; and

(d) regardless of when it came into existence;

**"responsible party"** means a public or private body or any other person who, alone or in conjunction with others, determines the purpose of and means for processing personal information;

### 3. PURPOSE FOR THE COLLECTION

3.1 The purpose for the collection of your Personal Information and the reason why FFC requires your Personal Information is to enable FFC to:

3.1.1 comply with lawful obligations, including all applicable labour, tax and financial legislation and/or the B-BBEE laws;

3.1.2 to give effect to a contractual relationship as between you and FFC and in order to ensure the correct administration of the relationship;

3.1.3 for operational reasons including the conducting of research;

3.1.4 to protect the legitimate interests of FFC, yourself or a third party;



3.2 All Personal Information which you provide to FFC will only be used for the purposes for which it is collected.

#### **4. CONSEQUENCES OF WITHOLDING CONSENT OR PERSONAL INFORMATION**

Should you refuse to provide FFC with your Personal Information which is required by FFC for the purposes indicated above, and the required consent to process the aforementioned Personal Information, then FFC will be unable to engage with you or enter into an agreement or relationship with you.

#### **5. STORAGE AND RETENTION AND DESTRUCTION OF INFORMATION**

5.1 All Personal Information which you provide to FFC will be held and/or stored securely and held for the purpose for which it was collected, as reflected above.

5.2 Your Personal Information will be stored electronically in a centralised data base, which, for operational reasons, will be accessible to authorised persons within FFC.

5.3 Where appropriate, some information may be retained in hard copy.

5.4 In either event, storage will be secure and audited regularly regarding the safety and the security of the information.

5.5 Once your Personal Information is no longer required due to the fact that the purpose for which the information was held has expired, such Personal Information will be safely and securely archived for a period of 5 years or longer, especially should this be required by any other law applicable in South Africa.
